### 2. Why do we process your personal data?

### 3. How long do we keep your data?

We keep the data while you do not communicate your wish to delete them and for the years required to meet legal obligations.

## 4. What is our legal entitlement to process your data?

We indicate the legal basis for processing your data:

- Legitimate interest of the Party responsible: Sending of commercial communications

## 5. What addressees receive your data?

Data is sent to the following addressees:

# 7. What are your rights when you provide us with your data?

Any person has the right to obtain confirmation on whether in CASTILLA TERMAL S.L. we are processing or not personal data that concerns you.

Interested parties have the right to access their personal data, as well as to request rectification of inaccurate data or, if applicable, to request their deletion when, amongst other motives, such data are not longer necessary for the purposes for which they were collected. You also have the right to the portability of your data.

Under certain circumstances, interested parties may request restriction on the processing of their data, in which case we will only keep them to file or defend ourselves against complaints.

Under certain circumstances and for reasons related to individual situations, interested parties may oppose the processing of their data. In this case, CASTILLA TERMAL S.L. will refrain from processing the data, except when there are overriding legitimate grounds, or the right to file or defend ourselves against possible complaints.

Where commercial communications are sent on the basis of the data controller's legitimate interest, the interested party may object to the processing of their data for that purpose.

If you have granted your consent for a specific purpose, you have the right to withdraw the granted consent at any time, without detriment to the legitimacy of the processing based on the consent prior to withdrawal.

If you feel that your rights have been violated in regard to the protection of your personal data, especially when you have not obtained satisfaction in the exercise of your rights, you can submit a claim before the competent Control Authority for Data Protection through its website: www.agpd.es.
